(क) "अधिनियम" से आशय वास्तुविद अधिनियम, 1972 (1972 का 20) से है;
(ख) "मूल संकाय" से आशय संस्थान द्वारा नियमित आधार पर नियुक्त, परिषद् के साथ वैध पंजीकरण वाले पूर्णकालिक अध्यापक-वर्ग के सदस्यों से है;
(ग) "परिषद्" से आशय अधिनियम की धारा 3 के अधीन गठित वास्तुकला परिषद् से है;

GUIDELINES FOR CONDUCT OF**PRACTICAL TRAINING AND ARCHITECTURAL DESIGN THESIS**

1. **PRACTICAL TRAINING**—(1) Practical Training shall be undergone during 8th/ 9th semester of the Architecture Degree course for a period of six months or one semester in the office of an architect or an organization operating in an allied field of practice or research, duly approved by the institution, under mentorship of an architect having experience of at least 5 years.
 - (2) The practical training shall be supervised and evaluated through periodic assessment by the mentoring architect and end semester examination (viva voice) as part of curricular studies.
 - (3) Training in Foreign Country shall be done under the Registered Architect of that Country and to be approved and monitored by the Head of the University or Institution.
2. **ARCHITECTURAL DESIGN THESIS** – (1) The Architectural Design Thesis shall be prepared under the guidance of a core Faculty member.
 - (2) The University or Institution shall conduct the internal evaluation at stages for the Architectural Design Thesis with the guide as a co-assessor.
 - (3) A jury comprising of an internal and external examiner and the guide shall conduct the final examination (Viva-voice) of the Architectural Design Thesis. External Examiners shall have minimum 10 years' experience.
 - (4) Practical Training shall be completed before the commencement of Architectural Design Thesis.

1. Only candidates registered with Council under the provisions of the Architects Act, 1972 shall be eligible for the core faculty posts subject to minimum qualifications, pay and experience as prescribed in Appendix B.
2. In addition to above, approximately 25 per cent. of the teaching load should be allotted to the Visiting faculty drawn from profession.
3. Full time faculty may be recruited in the allied areas from the field of Engineering, Fine Arts, Humanities, etc. provided that there is a minimum of 12 core full time faculty along with Head for an intake of 40. The faculty from allied areas shall not exceed more than 3 for an intake of 40, 6 for an intake of 80 and 9 for an intake of 120. Further, they should be appointed only at the posts of Associate Professor and Assistant Professor in the cadre ratio of 1:2. The minimum qualifications and experience required for appointment of these faculty shall be as per All India Council for Technical Education (AICTE) or University Grants Commission (UGC) Norms, as the case may be. However, the concerned faculty should have the minimum qualification in the respective field(s) at Bachelor's and/or Master's level with at least 60 per cent. marks at either level.
4. To maintain teacher and student ratio of 1:10, the institution shall have requisite number of visiting faculty teaching equivalents in addition to Full time teaching staff.

5. One Professor Design Chair for every intake of 40 students can be appointed and shall be counted against Professor Cadre.
6. Professor Design Chair and other faculty members appointed on tenure basis cannot be considered as Head of the Institution or Principal or Dean or Head of Department.
7. Upto 50 per cent. of the faculty members other than Professors (excluding Professor Design Chair) can be on tenure basis.


I have to state that the Council of Architecture had prescribed the Council of Architecture (Minimum Standards of Architectural Education for Post-Graduate Programmes) Guidelines, 2006 under the provisions of the Architects Act, 1972 in the year 2006 in order to lay down Norms for imparting 2-year Post – Graduate Degree Programme in Architecture i.e. M.Arch. degree course in the country.

As the Post-Graduate Programmes in Architecture have undergone a considerable change during the past decade, the Council of Architecture at its 78th meeting held on November 7, 2022 considered and approved "Council of Architecture (Minimum Standards of Architectural Education for Post – Graduate Degree Programme) Guidelines, 2022". These Guidelines have been prescribed by the Council in exercise of the powers conferred under Section 21 of the Architects Act, 1972 and are to be adhered to by all the universities, institutions and competent authorities for imparting M.Arch. degree courses from the academic session 2023-2024. A copy of these Guidelines is attached herewith for your ready reference.

In view of the above, all institutions and universities imparting M.Arch. degree course as well as competent authorities in the Central/State Governments are requested to implement Council of Architecture (Minimum Standards of Architectural Education for Post – Graduate Degree Programme) Guidelines, 2022 issued by the Council and ensure that the same are duly followed by the concerned institution/University for imparting the M.Arch. degree course in the country.

Notes:

- (i) Every University or Institution should have Head of the Institution (HOI) and HOI will be registered with Council under provisions of Architects Act, 1972. The HOI will be common for Undergraduate and Postgraduate Degree programme. The HOI will be full time core and not be on tenure basis.
- (ii) Only candidates registered with Council under provisions of Architects Act, 1972 shall be eligible for core faculty posts subject to minimum qualifications, pay and experience as prescribed in Appendix B.
- (iii) The above dedicated core faculty requirement is to be made available at the time of inspection for application of the division.
- (iv) Additional division for the existing Post graduate degree programme will be granted only after completion of 3 years from approval/commencement of the course.
- (v) Teacher - Student ratio for studio subject shall be 1:5 and for theory subjects shall be 1:20. The load allotted to each visiting faculty as well as experts from the profession / industry shall be clearly indicated by the University/ Institution in addition to the core faculty so as to achieve and maintain the stipulated ratios.
- (vi) Visiting faculty may be recruited from allied areas from the field of related specialization and as per the requirement of curriculum such as Law, Horticulture, Engineering, Fine Arts, Humanities etc. depending on actual requirements of the programme subject to minimum qualifications, pay and experience as prescribed in Appendix B.
- (vii) Up-to 50 percent of faculty members can be on tenure basis of 3 years. Faculty members appointed on tenure basis can be reappointed by Selection Committee comprising of CoA Nominee after completion of tenure period.
