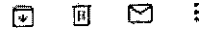

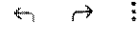

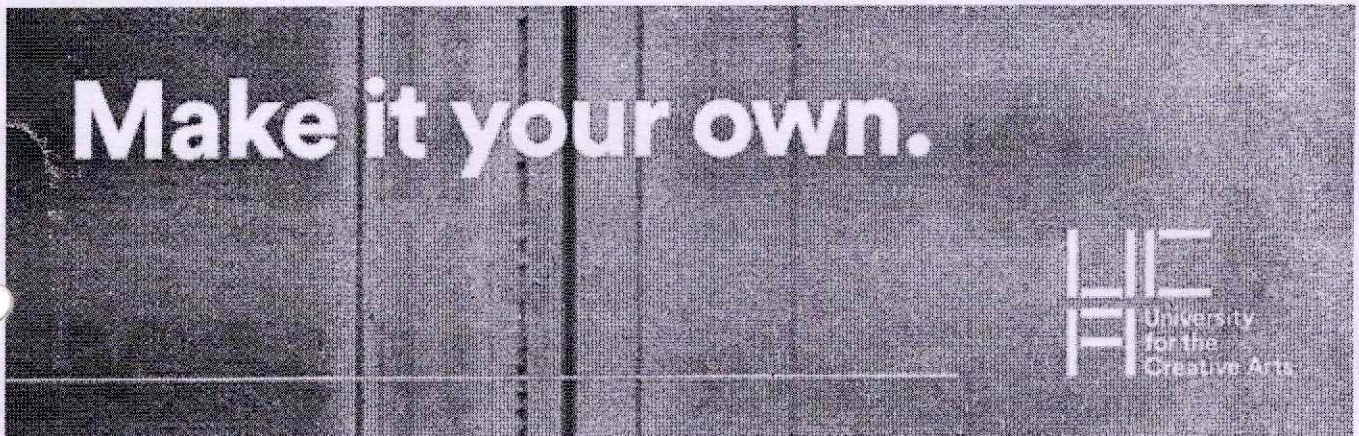

### **Your Biometric Residency Permit**

The UK Government requires you to have a Biometric Residency Permit (BRP) that covers the length of your stay in the UK. You will first be issued a travel vignette (sticker) in your passport that allows you to travel to the UK. You will then have to collect your BRP from a Post Office after entering the UK. If you are coming from a country that is on the UK COVID quarantine list, at the time of your arrival, you must quarantine/self-isolate for the required period, inside your residence in the UK. Only after the quarantine period should you go out to collect your BRP.

During your UK Visa application you will be asked for a UK Post Code to select which Post Office you will collect your BRP from. We strongly suggest you use the postcode of the University Campus as this will give you the closest Post Office to where you will be studying. The following suggestion may not be the closest Post Office in distance but they are the easiest to get to using Public Transport (bus/train/walking). Alternatively, if you are living in private accommodation, you may wish to choose a post office closer to that.

Canterbury: The postcode for the Canterbury Campus is CT1 3AN. The collection location you should then choose will be: 19 St George Street, Canterbury, CT1 2LB. This is a short 10 minute walk from the campus. Further information will be provided in your welcome pack on how to get to the Post Office.

If you are studying a Pre-session English course before your main course of study, the location you should choose to collect your BRP should be the closest Post Office to your Pre-session course campus. For Farnham, the postcode is GU9 7DS and the closest Post Office is 56 High Street, Guildford, Surrey GU1 3ES, a 23 minute train journey from the Farnham campus. For Rochester the postcode is ME1 1DZ and the closest Post Office is 17 - 19 Military Road, Chatham, ME4 4JG, a short 10 minute walk from the campus.

You should also check your travel vignette as soon as you receive it to check that the correct conditions (working hours/police registration/name spelling/sponsor license number) are noted on it. 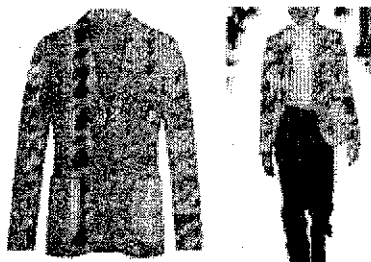




