
The conditions said down by the local inquiry committee are as follows.

- It will be mandatory to maintain the required NAAC INBA assessment / Re assessment by your college if this is not fulfilled the proposal will not be accepted after further consideration.
- 3. It is to be seriously noted that in case of obtaining less than 65% in from A B or C for the next three Consecutive years from the academic year 2019-20, a proposal for the process of deregistration under section 120 of be submitted before the university authority Board.
