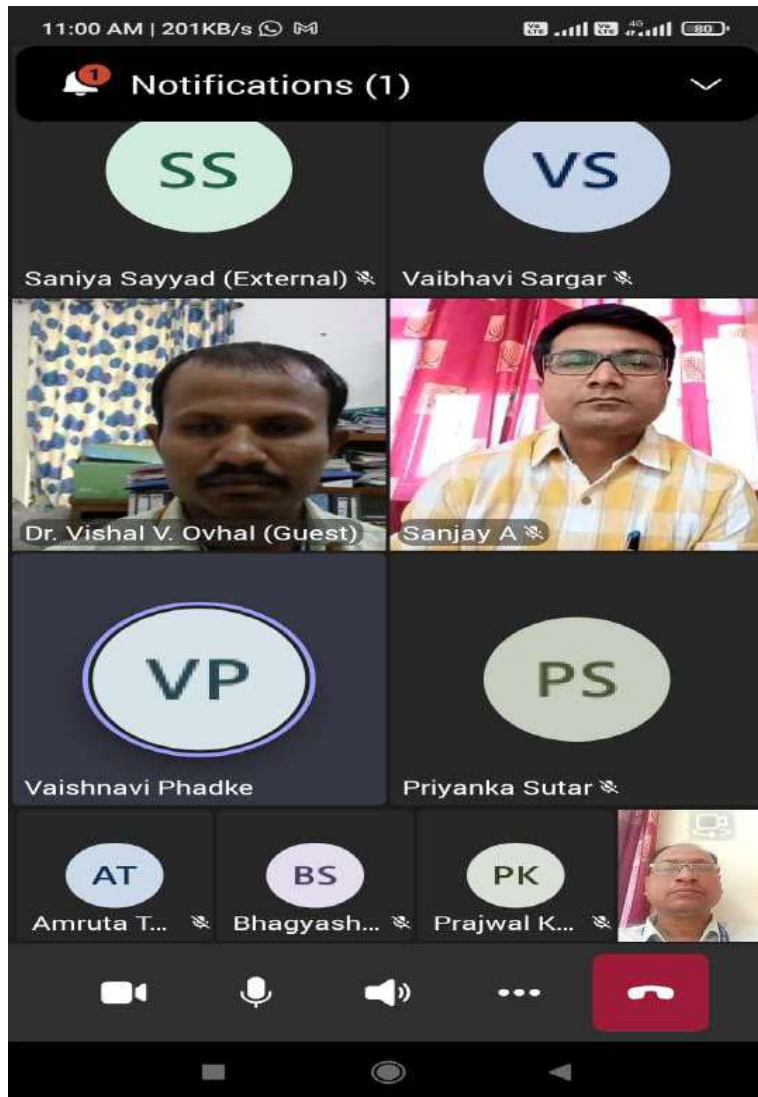

When students develop their own research agenda, engage in critical thinking and test their interpersonal skills, they come face to face with an alternative worldview, learning through both action and reflection, including the consequences of the larger social and ethical implications of this knowledge. This type of learning engages students in a deliberate process of hands-on problem solving and critical thinking. It often evolves with a minimum of the usual institutional structure dictated to the student



in advance of the learning experience. 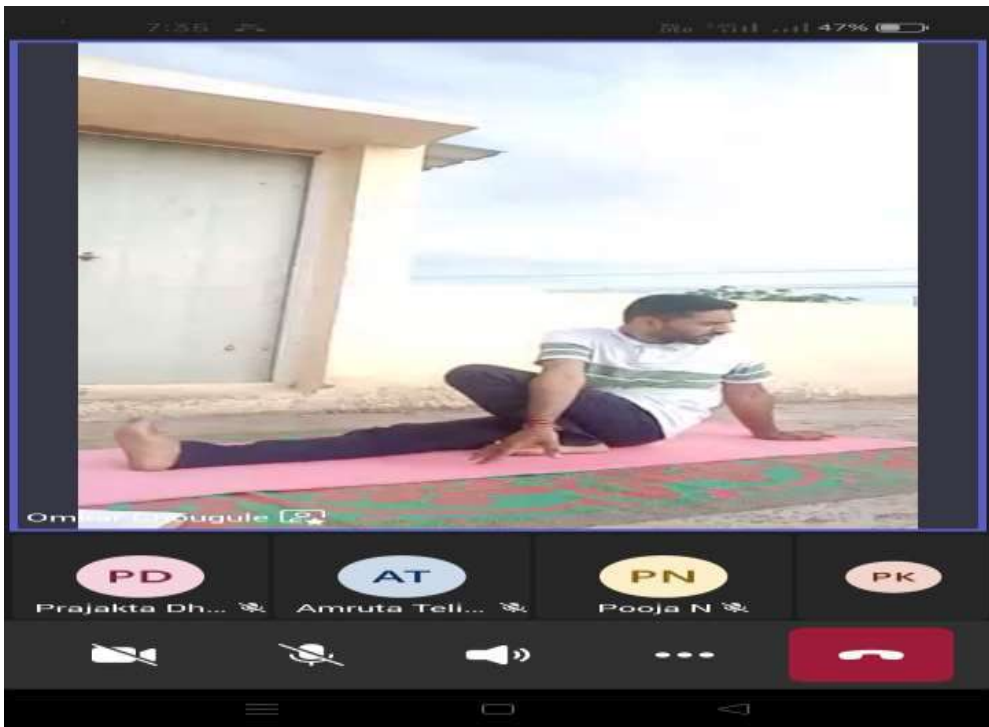
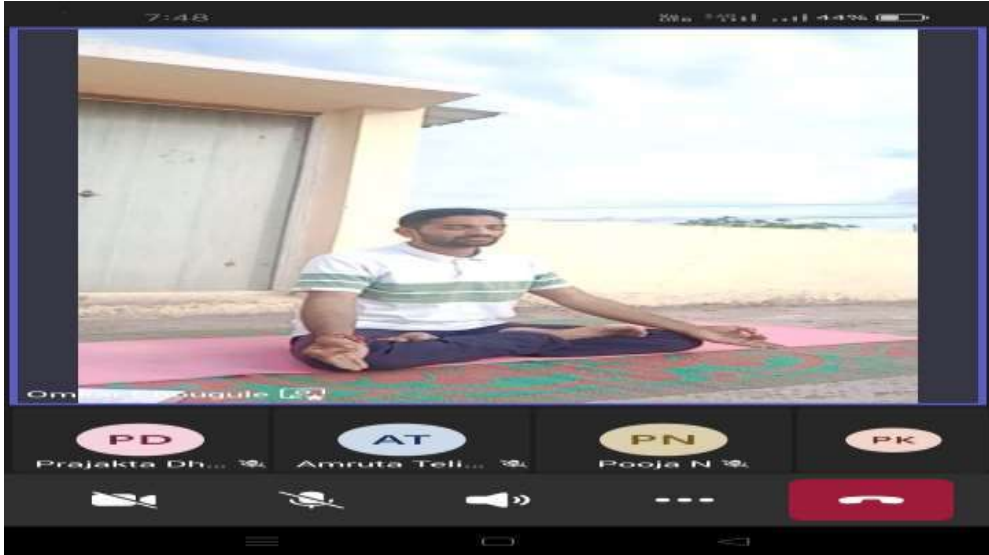

Event 35 : Human Rights Day Celebration Saturday, 10th December,2022

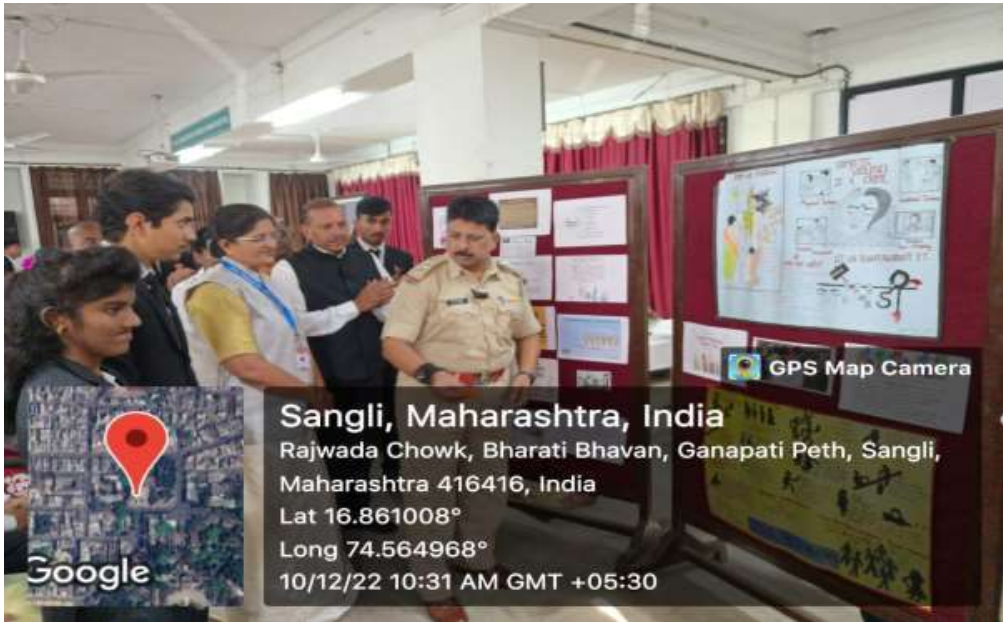

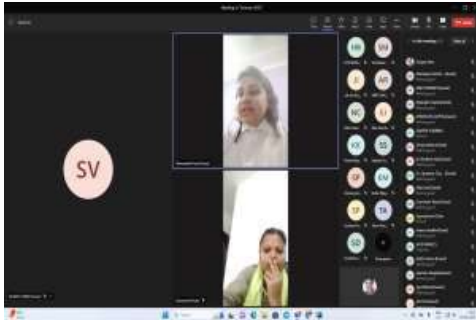
