The college was established in the year 1997 with the object of providing legal professionals and social engineers to fulfill the dream of ‘ *Social Transformation through Dynamic Education*’ of Hon’ble Dr. Patangrao Kadam, Founder of Bharati Vidyapeeth, Pune and the Chancellor of Bharati Vidyapeeth University, Pune. The main objective behind establishment of this college is to provide opportunity to rural masses that were outside the stream of education by providing quality legal education for Social transformation.

Initially in 1997, the college commenced the Under-Graduate Three Years Law course (LL.B.). The Five Years Law Course was started with the recognition of Government of Maharashtra and approved by the apex body Bar Council of India in 2001-02.

I am happy to let you know that the college has been accredited with NAAC, ‘A’ grade and while moving towards excellence we are taking every possible effort.

In academic year 20-21, Admission process was conducted as per CET Cell Government of Maharashtra. Every year ,the college conducts skill enhancing short term courses like Cyber law, Proficiency in the use of English, Yoga and Advocacy skill with active support and guidance from the Department of Adult, Continuing Education and Extension Work, Shivaji University, Kolhapur. This year, due to Covid-19 only the short term course , Proficiency in the Use of English was conducted .

**CO-CURRICULAR ACTIVITIES:**

To prepare the students to face the challenges in the competitive world, the college organizes different co-curricular activities. The students are encouraged to participate in Moot Court and Mock Trial and other competitions held at National, State and Local level.

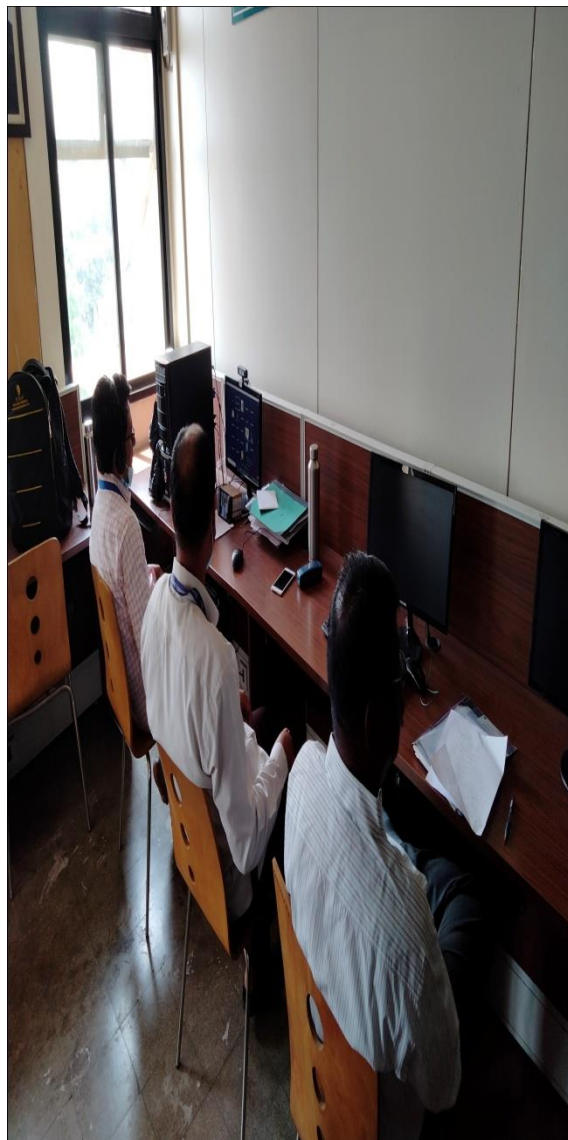
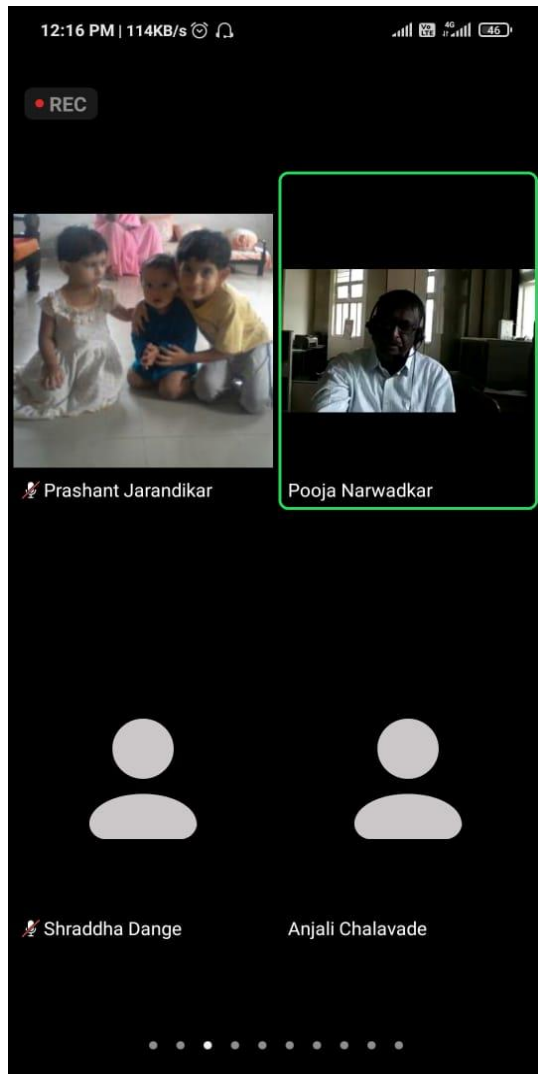
### **Career Opportunities in Banking & Financial Sector**

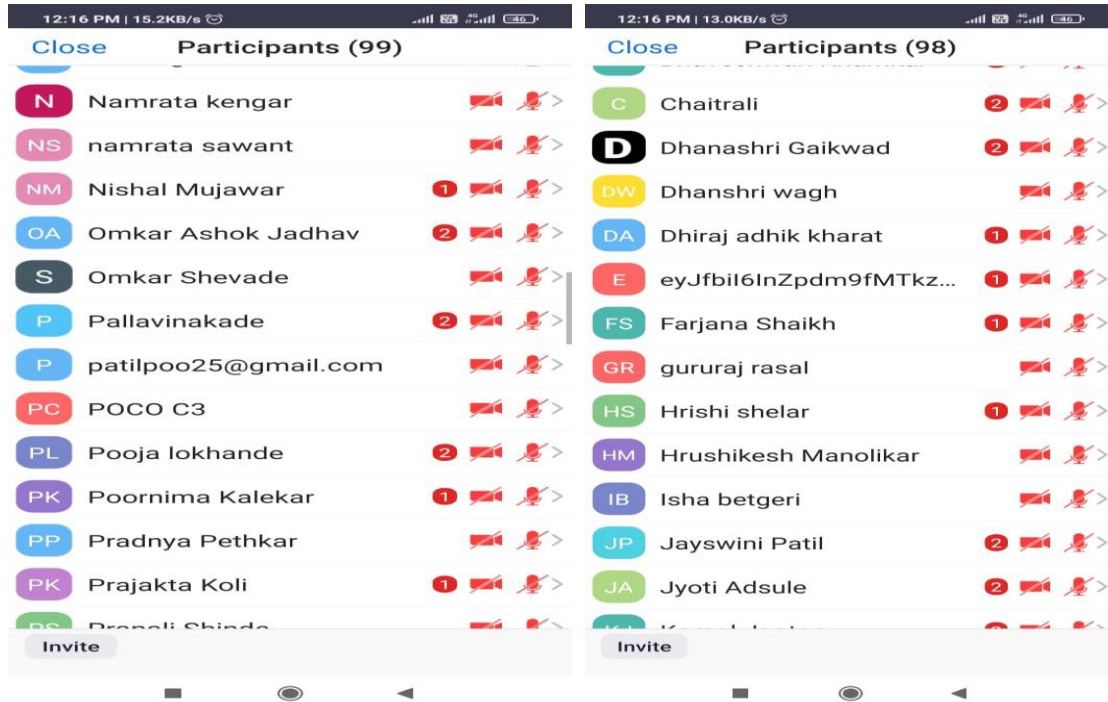


For the second session the college invited our star alumni, Hon. Prashant Jagtap , to guide the students . He enlightened the students about how legal education can

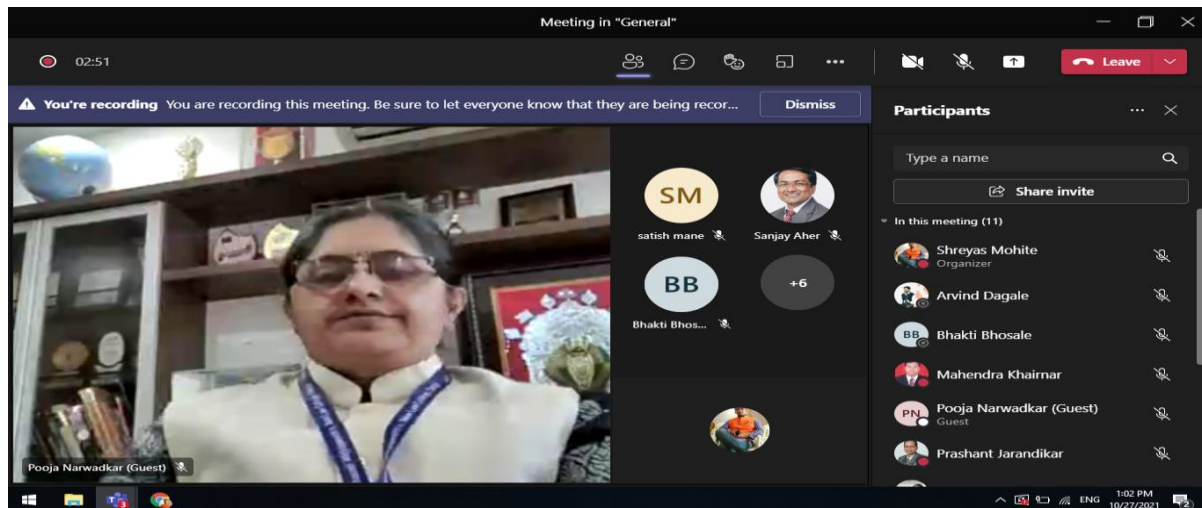

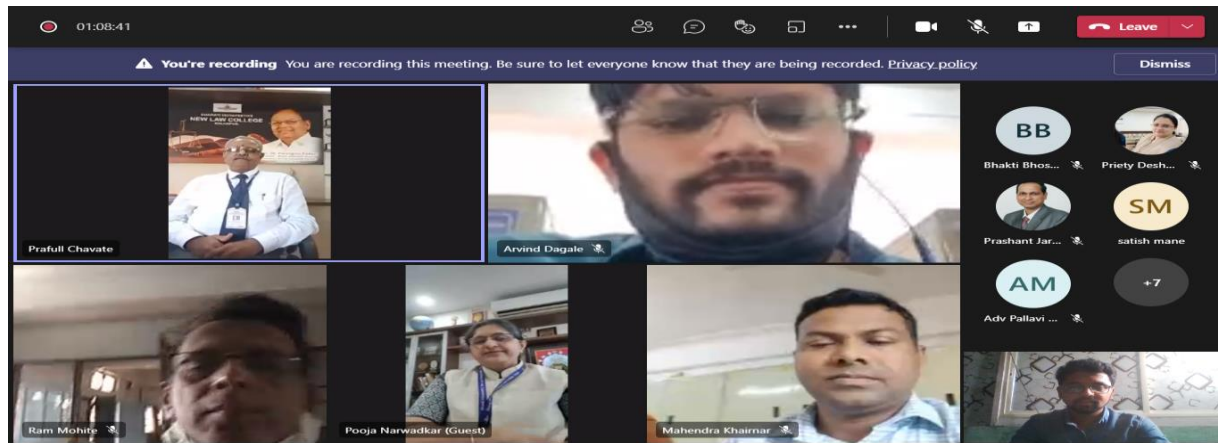
**FDP: Challenges of Online Examinations and Drafting MCQs**

The program was conducted in two sessions. In the first session Dr. Bhagyashree Deshpande guided the faculty members regarding how to frame MCQ's for online

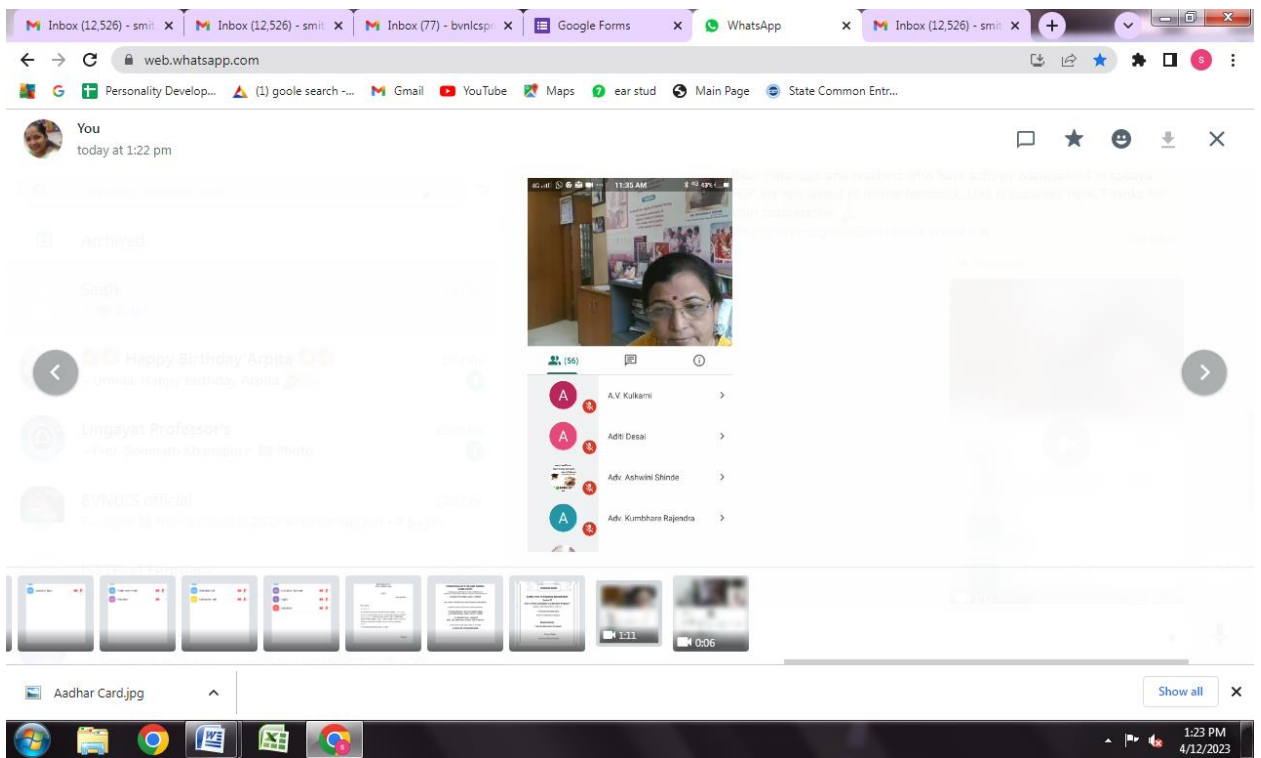
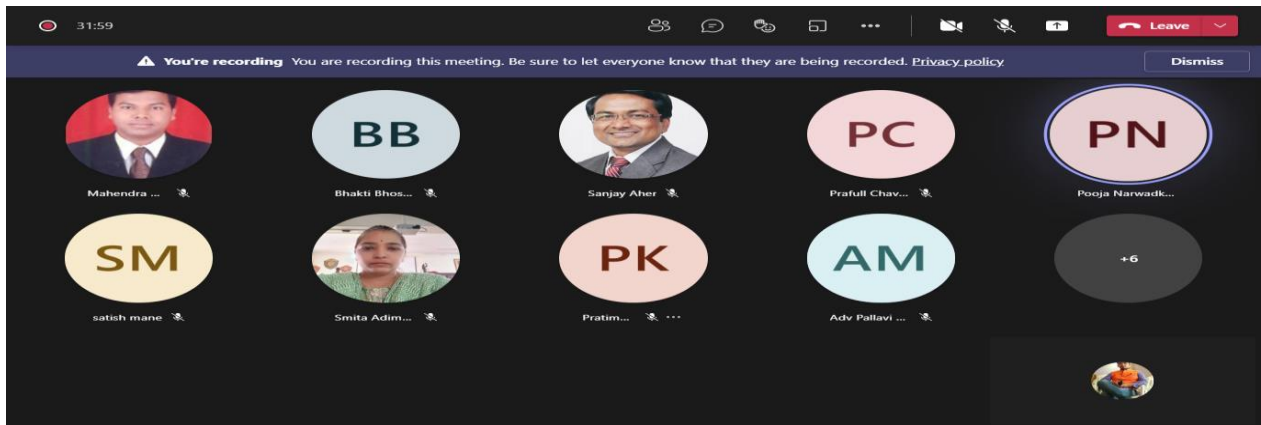
examinations as well she talked about does and don'ts to be considered while framing MCQ type question papers with examples.

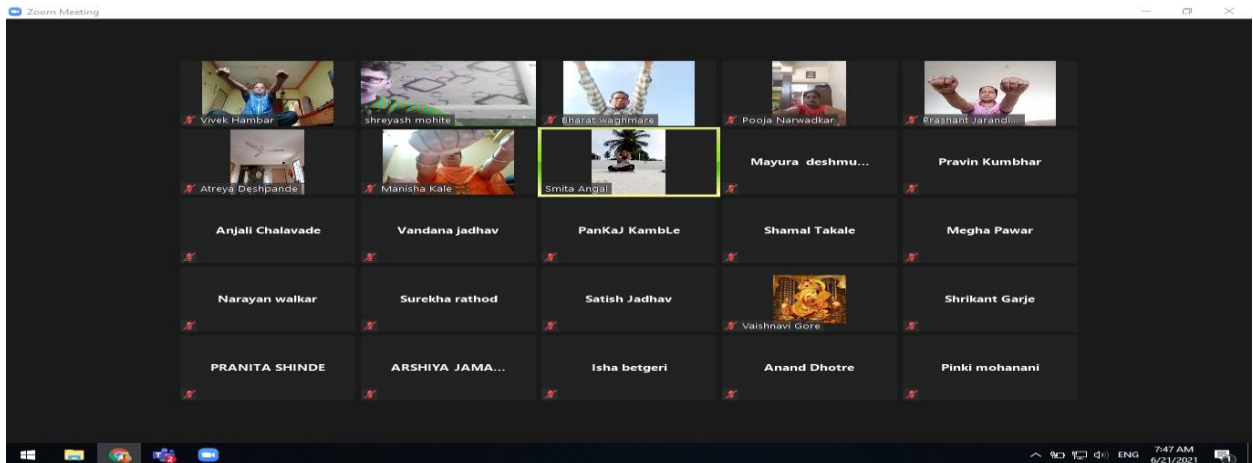

*On International Yoga Day celebrations*

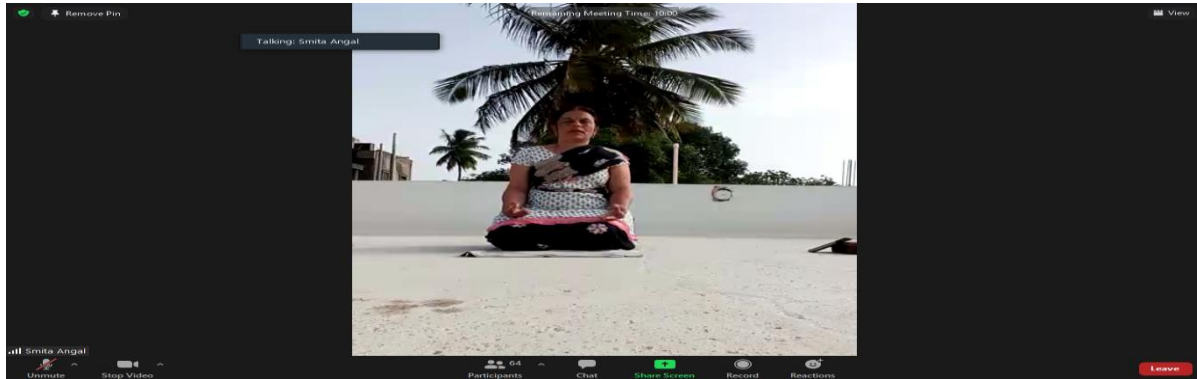
Monday, 21st, June 2021

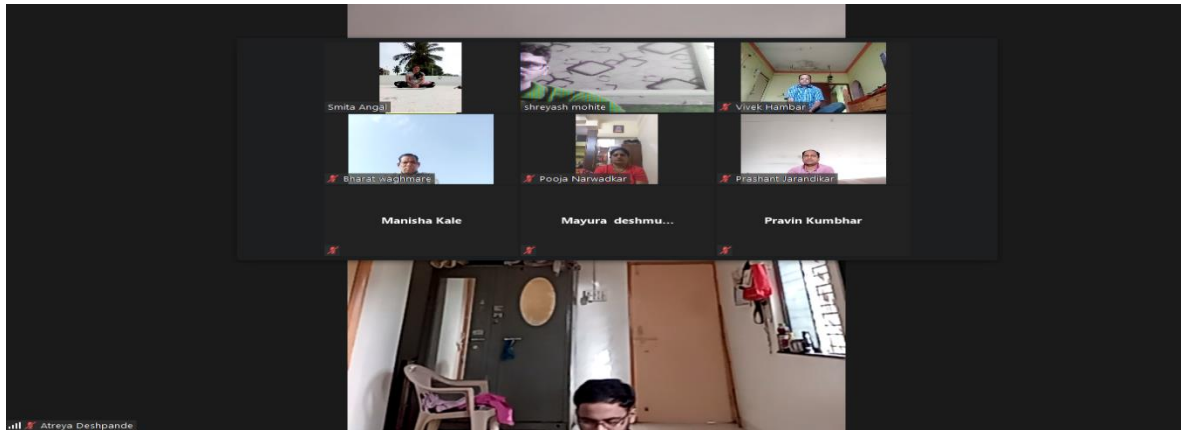

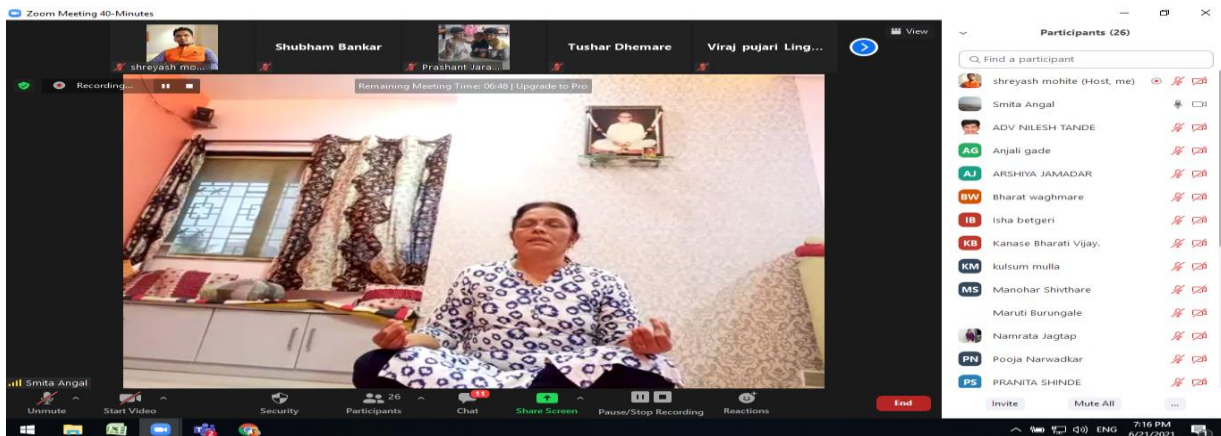

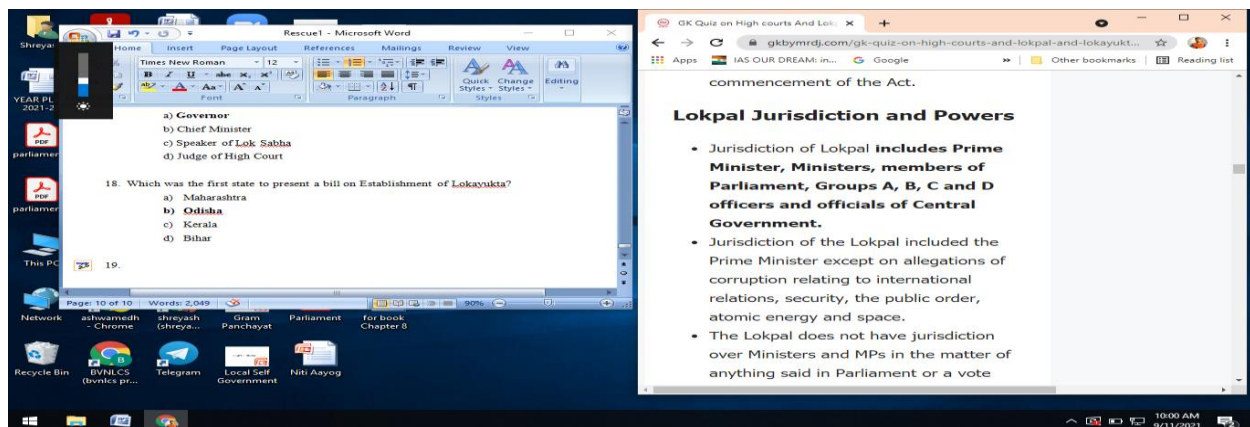

## **BVNLCS' NSS Unit organized '*Maze Gaon Coronamukt Gaon*' awareness activity**






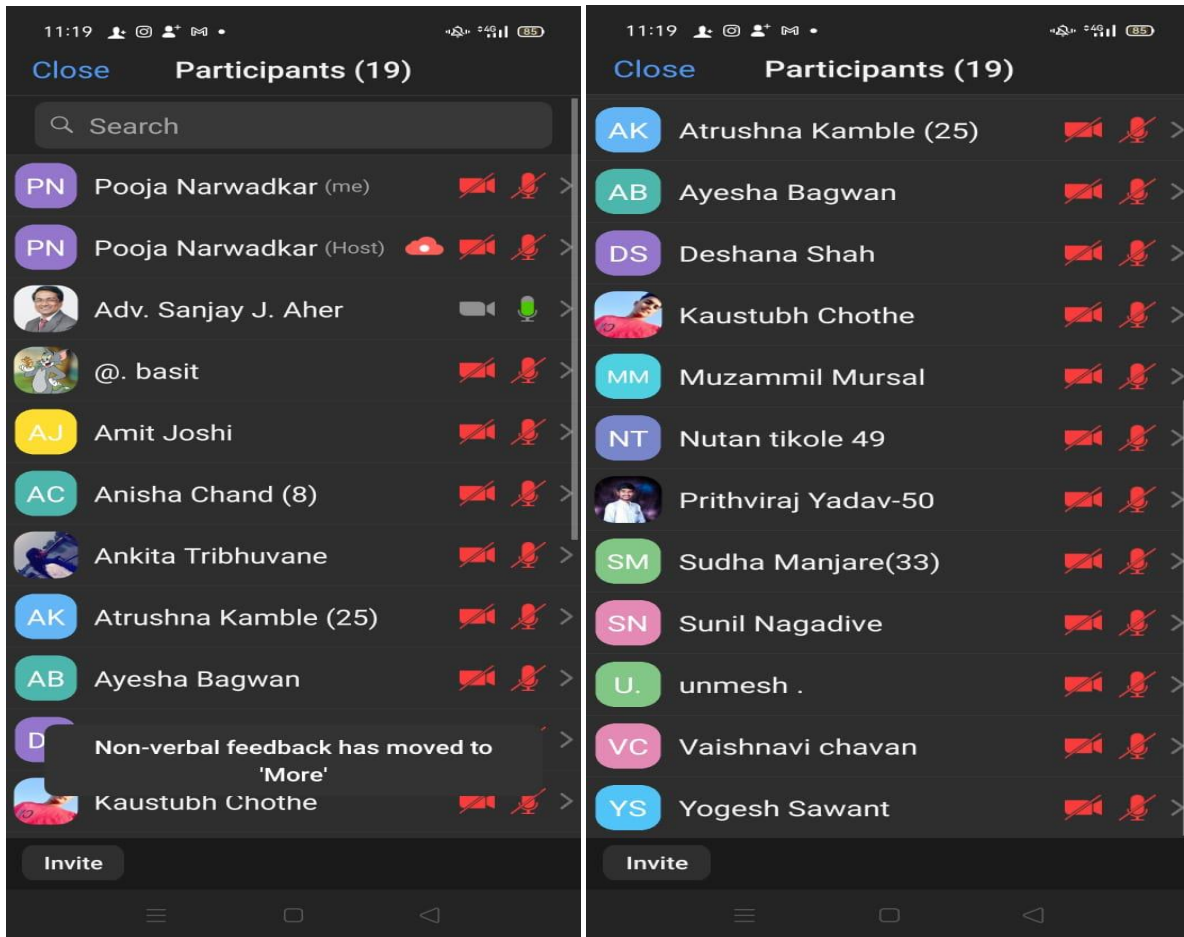
Nearly, 30 students registered for this debate competition and 9 students were shortlisted for the final round. The students presented their views in very bold manner and have provided examples and references to prove their point.

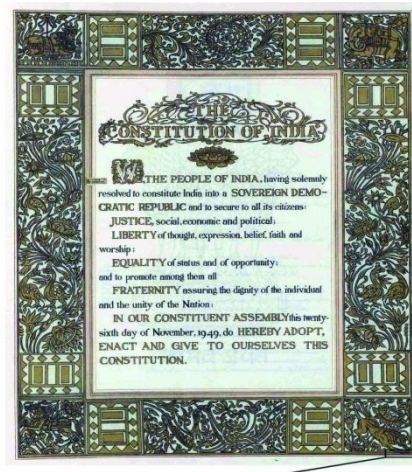

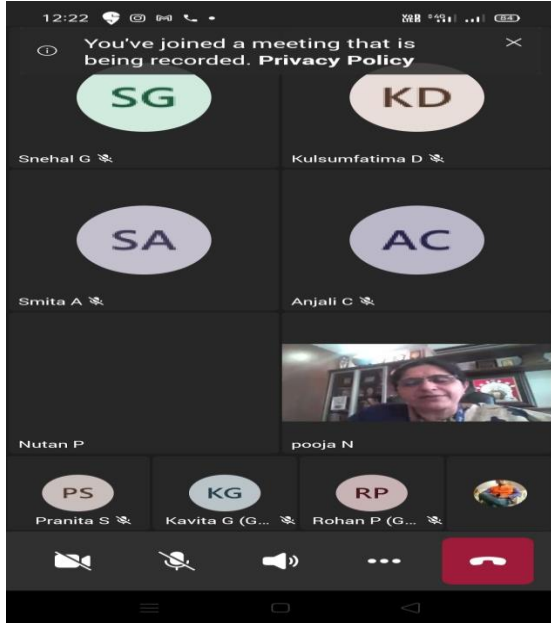
### **Seven days online Workshop for Personality Development**

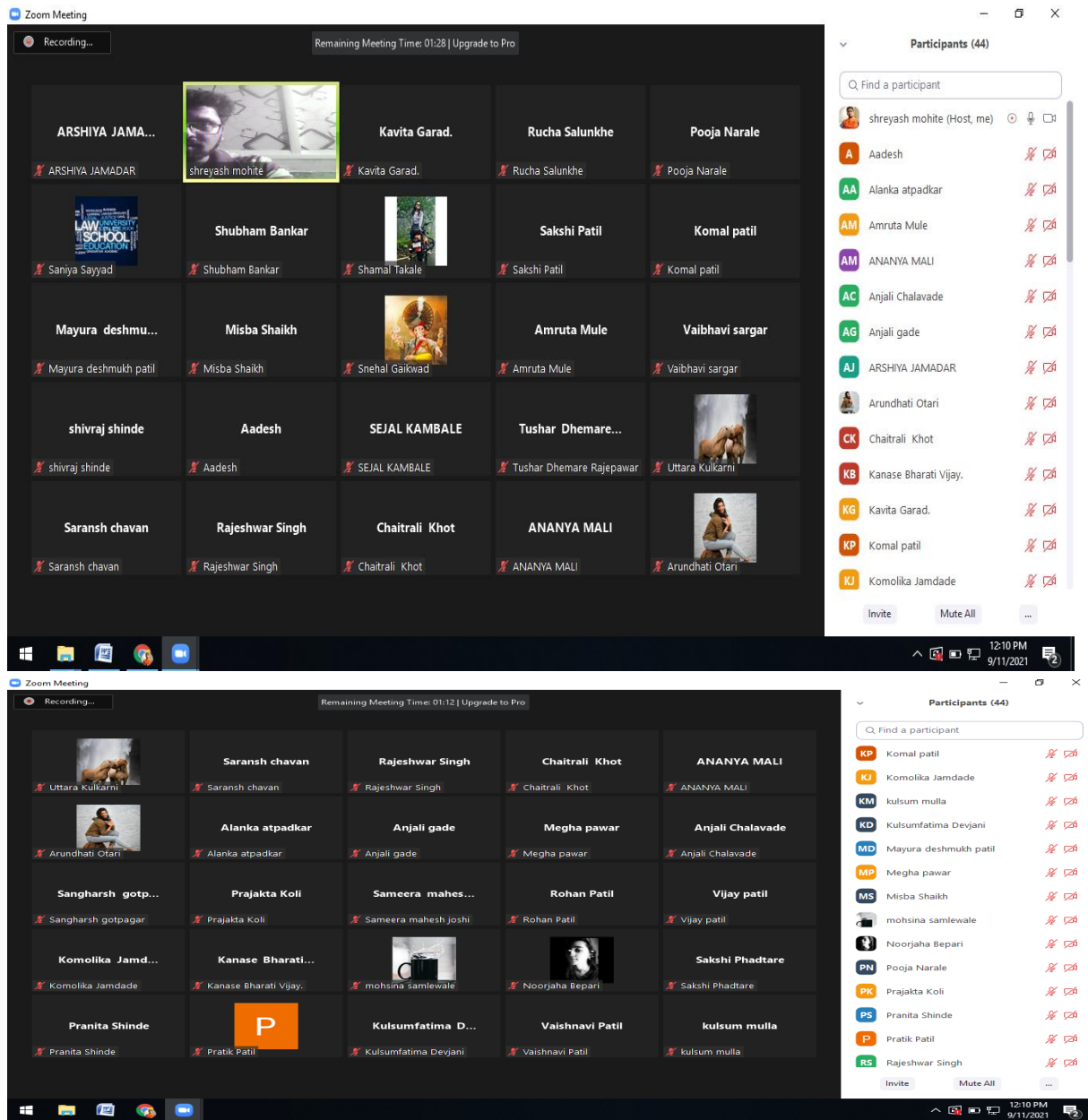

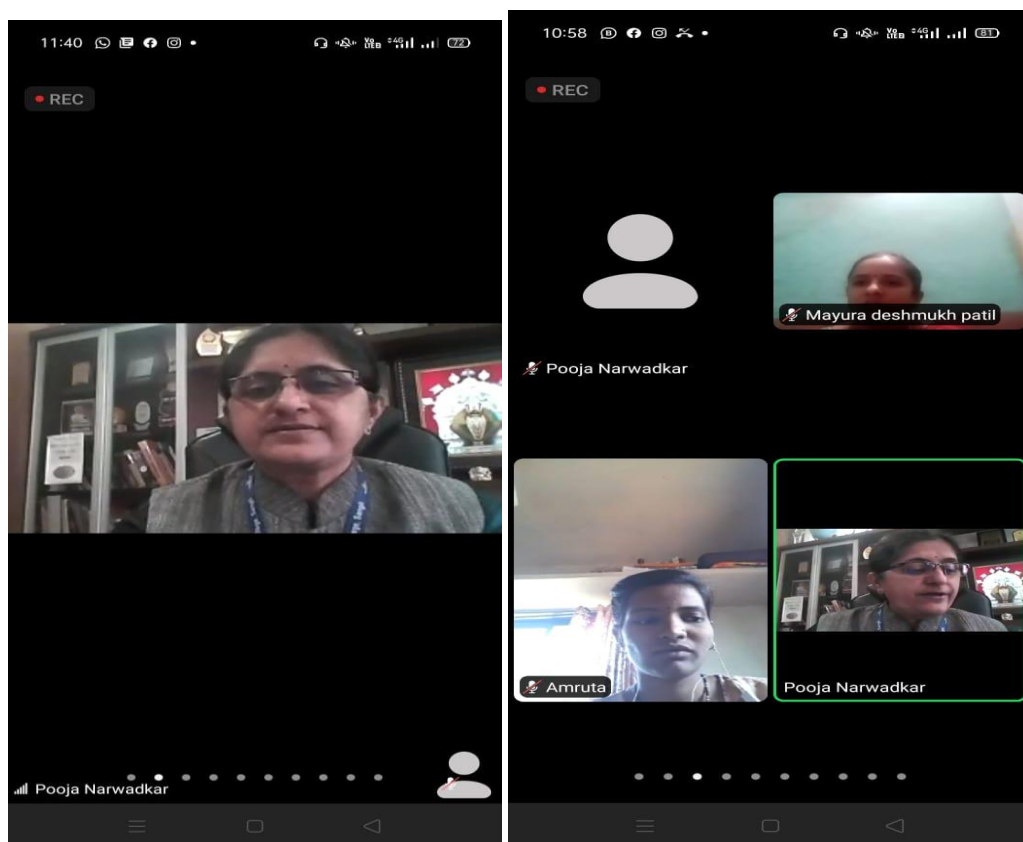

### Foundation Course to Groom the Novice

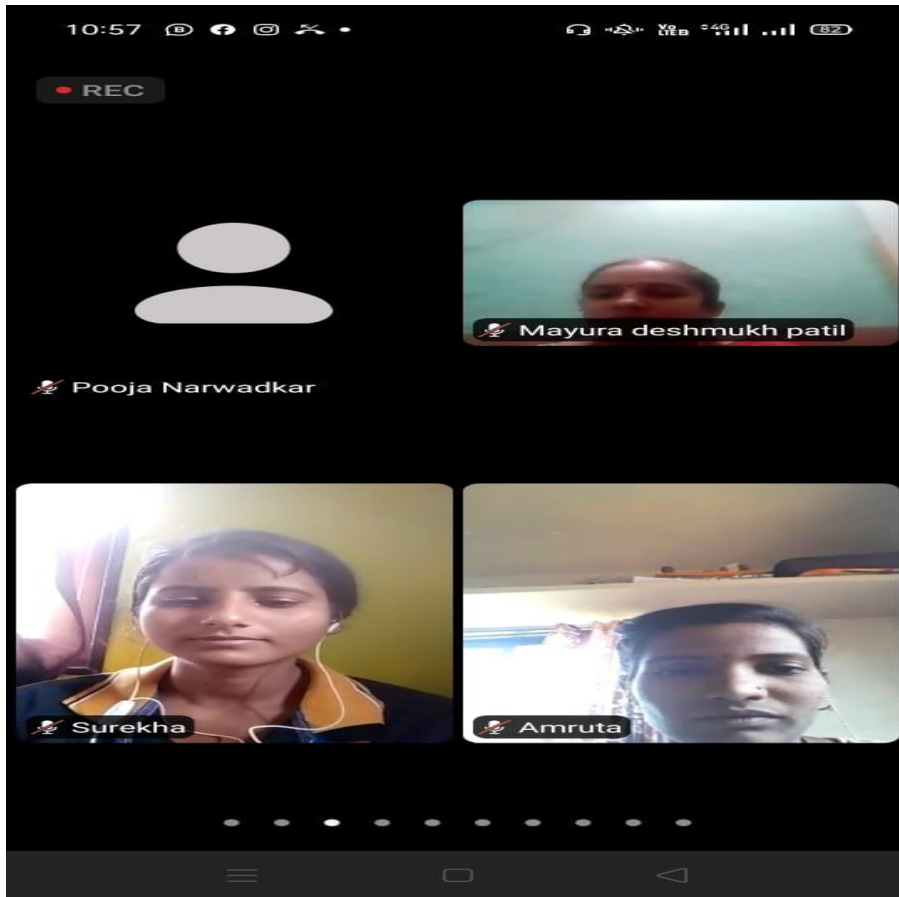
31<sup>st</sup> March, 2021 to 9<sup>th</sup> April

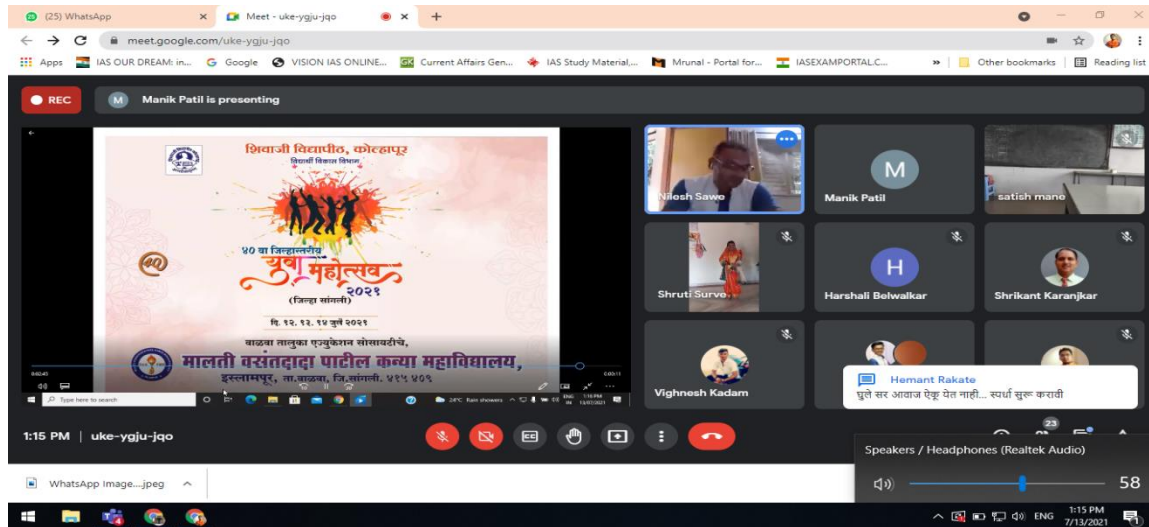

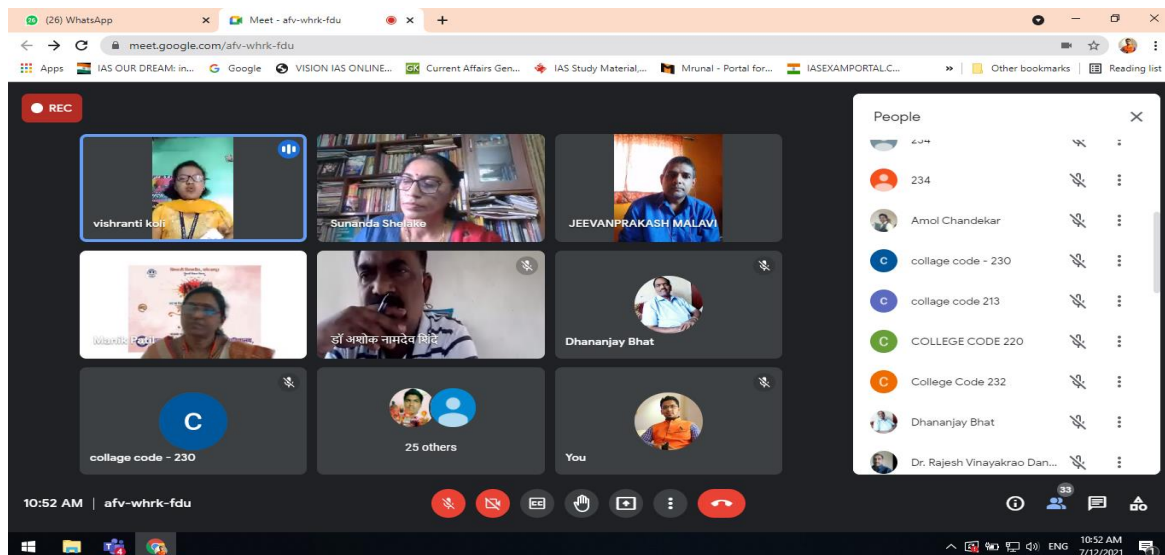

## On BVNLCS' Students win in SUK's Online Youth Festival 2020-21 at District Level

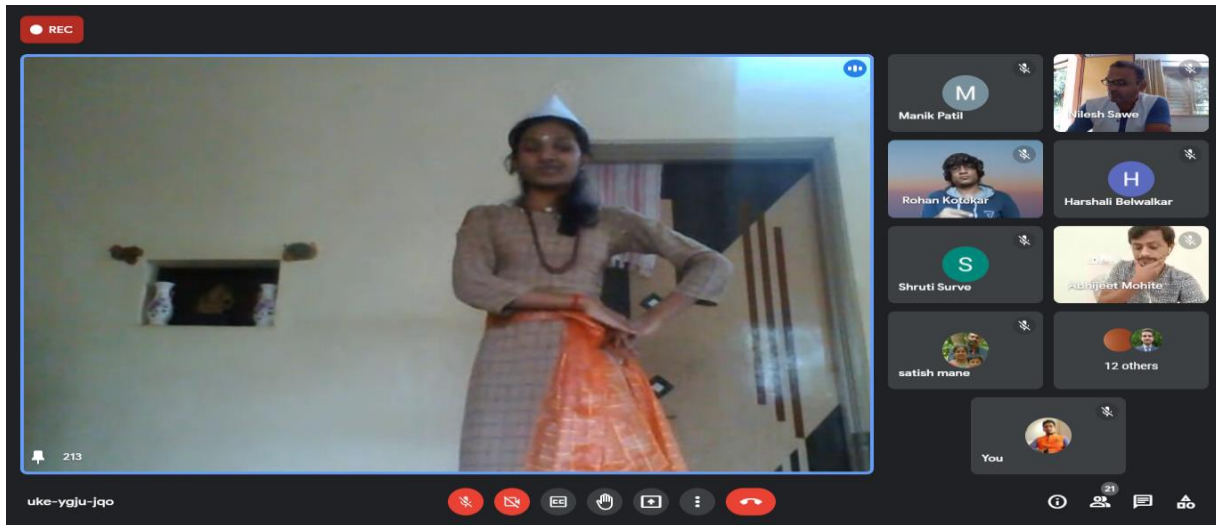

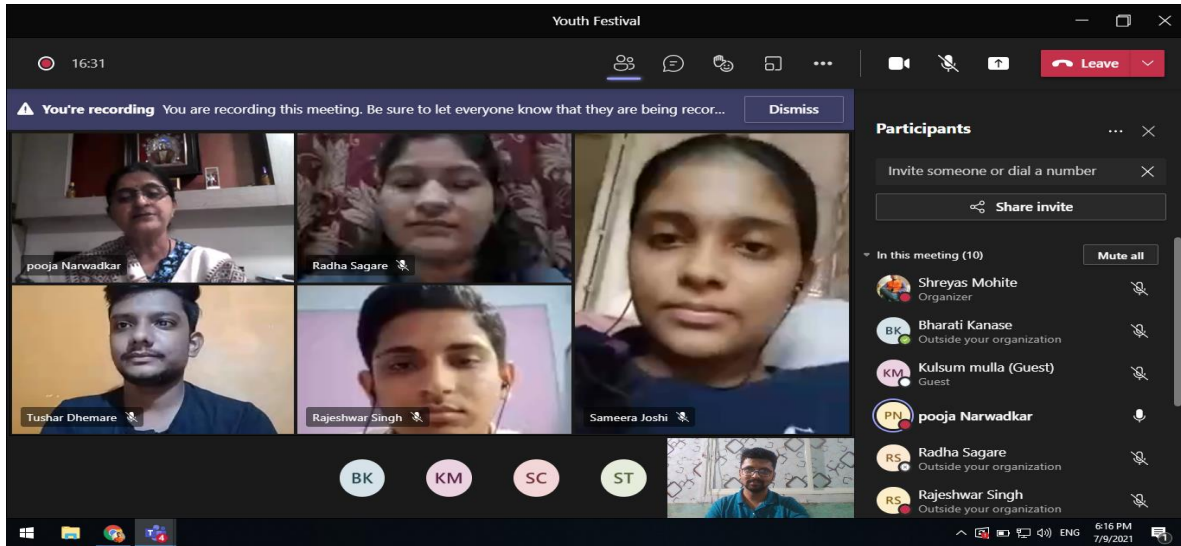

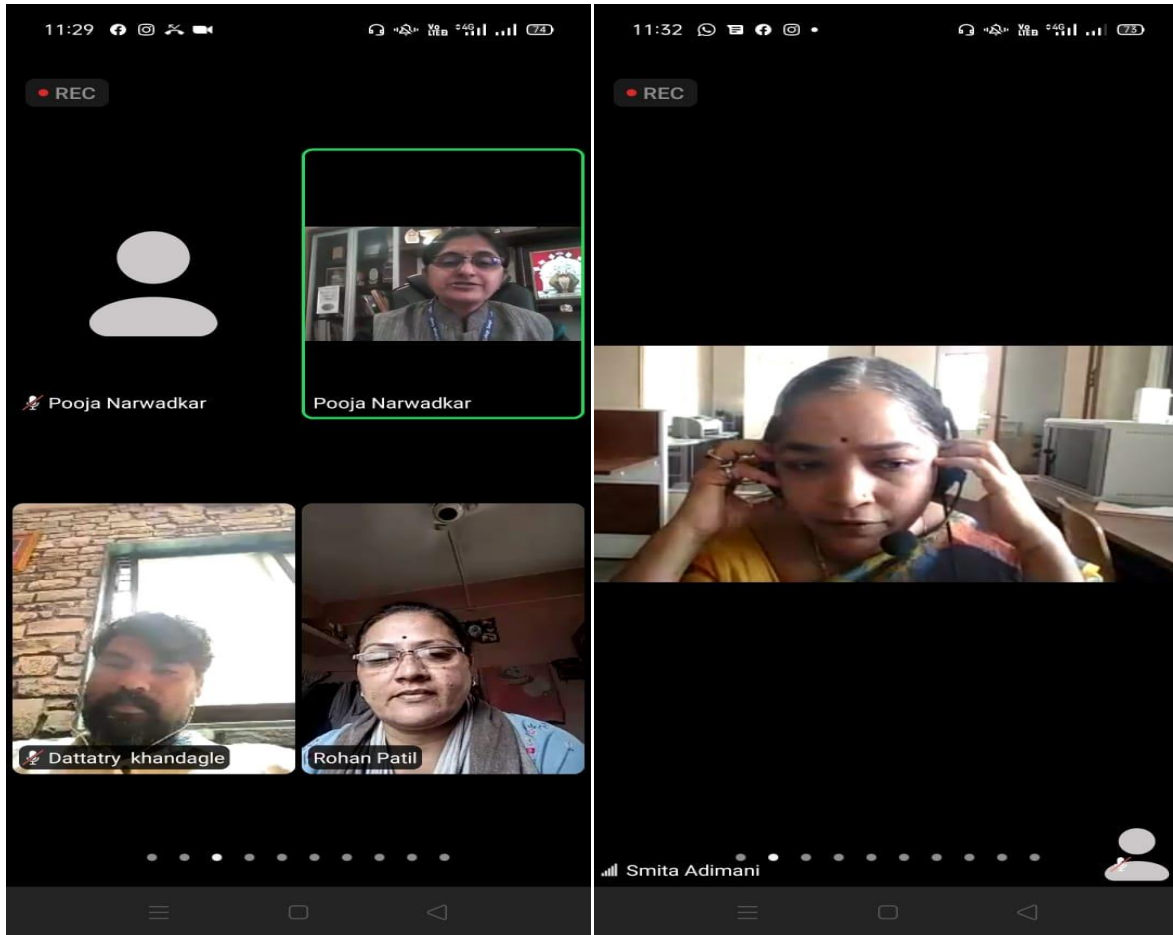

**Online Parents Meet**

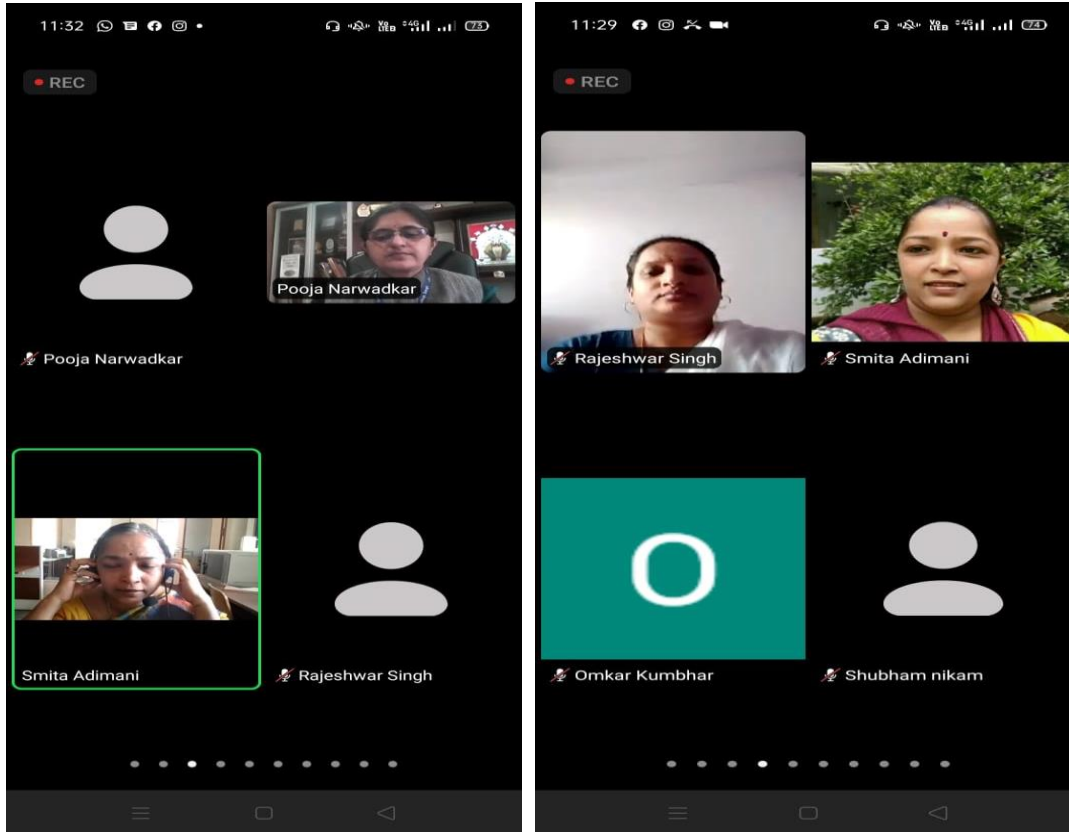
30<sup>th</sup> March, 2021
